**FIRE PROTECTION SYSTEM PERMITS** - (*Note: An additional 3% state tax shall be assessed for all fire protection permits*)

Automatic Sprinkler Review – Sprinkler Heads:	Fee:
1 to 20	\$ 65.00
21 to 200	\$135.00
201 to 400	\$195.00
401 to 600	\$260.00
Over 600	\$325.00 + .25 per head over 600

<u>Hydraulically Calculated Systems</u> – Multiply the above fee by 1.5

Automatic Sprinkler Systems W/Fire Pump – Above fee plus \$65.00

Standpipe System Review - \$65.00; with fire pump \$130.00

Yard Hydrant System - \$65.00

## Carbon Dioxide Suppression System -

- Pre-engineered system: \$65.00
- Engineered system: 1 to 175 # of agent = \$65.00 > 175# of agent = \$65.00 + .30 per pound
- <u>Halon Suppression System</u> Up to 35# of agent = \$65.00 > 35# of agent = \$65.00 plus .30 per pound
- $\frac{\text{Dry Chemical System} \text{Up to } 30\# \text{ of agent} + \$45.50}{> 30\# \text{ of agent} = \$65.00 \text{ plus } .30 \text{ per pound}}$

<u>Wet Chemical System</u> – Up to 3 gallons of agent = \$45.50 > than 3 gallons of agent = \$65.00 plus \$2.50 per gallon over 3 gallons

Over 10	\$65.00 plus \$1.00 per device over 10

Fire Suppression System Re-Inspection Fee - \$130.00 per regular work day not to exceed 8 hours.

## **TANK PERMITS:**

 $\begin{array}{l} \underline{\text{Tank Installation Fee (Outdoor):}} & \text{Up to 1,000 gallon} = \$65.00 \\ 1,001 \text{ to 3,000 gallon} = \$100.00 \\ 3,001 \text{ to 12,000 gallon} = \$130.00 \\ 12,001 \text{ to 20,000 gallon} = \$195.00 \\ 20,001 \text{ to 50,000 gallon} = \$260.00 \\ 50,001 \text{ to 100,000 gallon} = \$325.00 \\ \text{Over 100,000 gallon} = \$390.00 \end{array}$ 

Tank Installation Fee (Indoor)Up to 1,000 gallon = 65.001,001 to 3,000 gallon = 100.003,001 to 12,000 gallon = 130.0012,001 to 25,000 = 195.00

Install New Piping (Existing Tanks) - \$65.00 per tank system

Tank Removal, Abandonment, Place Temporarily Out-Of-Service or Dispose - \$65.00 per tank system

Tank Relining or Repair - \$65.00 per tank

Tank System Reinspection Fee - \$130.00 per regular work day not to exceed 8 hours.

## **MISCELLANEOUS:**

<u>After Hours Testing/Inspection/Fire Watch</u> - \$219.44 [minimum four hours], \$54.86 per hour. After four hours: billed at <sup>1</sup>/<sub>4</sub> hour increments.

<u>Hazardous Substance Permits</u> – Temporary (five days or less) = \$20.00 Fixed Facility (valid for 3 years) = \$65.00

Explosives Permits – Not to exceed one year = \$75.00; After hours demo = \$109.72 [min.of 2 hours].

Lasers [Class III & Class IV] - \$75.00; After hours demo = \$109.72

<u>Flame Effects</u> = Indoor/Outdoor - \$75.00; After hours demo = \$109.72

Dangerous Ordnance [Blasting Operations] - \$75.00 (not to exceed one year)

Special Inspection/Licensed Facilities - \$32.50

<u>Special Testing/Dry Standpipe Flow</u> – Up to 3 risers = \$300.00; \$100.00 for each additional riser.

Certificate of Qualification [Fire Protection System Maintenance or Management of Liquefied Petroleum Gas Systems (LPG)] - \$35.00 (annual permit)
