NOTICE OF PRIVACY PRACTICES  
FOR  
PROTECTED HEALTH INFORMATION

The Cleveland Division of Fire is required by law to maintain the privacy of certain confidential health care information, known as Protected Health Information or “PHI”, and to provide you with a notice of our legal duties and privacy practices with respect to your “PHI”. The Cleveland Division of Fire is also required to abide by the terms of the version of this Notice currently in effect.

**Uses and Disclosures of “PHI”:**

The Cleveland Division of Fire may use “PHI” for the purposes of treatment, payment, and health care operations, in most cases without your written permission. Examples of the use of your “PHI”:

- **For treatment:** This includes such things as obtaining verbal and written information about your medical condition and treatment from you as well as from others, such as doctors and nurses who give orders to allow us to provide treatment to you. We may give your “PHI” to other healthcare providers involved in your treatment, and may transfer your “PHI” via radio or telephone to the hospital or dispatch center.
- **For payment:** This includes any activities we must undertake in order to get reimbursed for the services we provide to you, including such things as submitting bills to insurance companies, making medical necessity determinations and collecting outstanding accounts.
- **For health care operations:** This includes quality assurance activities, licensing, and training programs to ensure that employees meet the standards of care and follow established policies and procedures, as well as certain other management functions.

**Use and Disclosure of “PHI” Without Your Authorization:**

The Cleveland Division of Fire is permitted to use “PHI” *without* your written authorization, or opportunity to object, in certain situations, and unless prohibited by a more stringent state law, including:

- For the treatment, payment or health care operations activities of another health care provider who treats you;

- For health care and legal compliance activities;
- To a family member, other relative, or close personal friend or other individual involved in your care if we obtain your verbal agreement to do so or if we give you an opportunity to object to such a disclosure and you do not raise an objection, and in certain other circumstances where we are unable to obtain your agreement and believe the disclosure is in your best interests;
- To a public health authority in certain situations as required by law (such as to report abuse, neglect or domestic violence);
- For health oversight activities including audits or government investigations, inspections, disciplinary proceedings, and other administrative or judicial actions undertaken by the government (or their contractors) by law to oversee the health care system;
- For judicial and administrative proceedings as required by a court or administrative order, or in some cases in response to a subpoena or other legal process;
- For law enforcement activities in limited situations, such as when responding to a warrant;
- For military, national defense and security and other special government functions;
- To avert a serious threat to the health and safety of a person or the public at large;
- For workers' compensation purposes, and in compliance with workers' compensation laws;
- To coroners, medical examiners, and funeral directors for identifying a deceased person, determining cause of death, or carrying on their duties as authorized by law;
- If you are an organ donor, The Cleveland Division of Fire may release health information to organizations that handle organ procurement or organ, eye or tissue transplantation or to an organ donation bank, as necessary to facilitate organ donation and transplantation;
- For research projects, but this will be subject to strict oversight and approvals;
- The Cleveland Division of Fire may also use or disclose health information about you in a way that does not personally identify you or reveal who you are.

Any other use or disclosure of “PHI”, other than those listed above will only be made with your written authorization. You may revoke your authorization at any time, in writing, except to the extent that The Cleveland Division of Fire may have already used or disclosed medical information in reliance on that authorization.

### **Patient Rights:**

As a patient, you have a number of rights with respect to your “PHI”, including:

- **The right to request privacy protection for “PHI”:** You may request that The Cleveland Division of Fire restrict information to a health plan. The Cleveland Division of Fire will generally agree to the request to restrict disclosure of “PHI” about you to a health plan if: the disclosure is for the purpose of carrying out payment or healthcare operations and is not otherwise required by law; and the

“PHI” pertains solely to a healthcare item or service for which you or person other than the health plan on behalf of you has paid the Cleveland Division of Fire in full.

- **The right to access, copy or inspect your “PHI”:** You may inspect and copy most of the medical information about you that the Cleveland Division of Fire maintains. If the “PHI” is maintained electronically, you may request an electronic form or format requested, if it is readily producible in such form or format. You may request that The Cleveland Division of Fire send your “PHI” to another person; your request must be in writing, signed by you and clearly identify the designated person and where to send the copy of the “PHI”. The Cleveland Division of Fire will provide you with access to this information within 30 days after receipt of your request. The Cleveland Division of Fire may also charge you a reasonable fee for you to copy any medical information that you have the right to access. In limited circumstances, the Cleveland Division of Fire may deny you access to your medical information, and you may appeal certain types of denials. The Cleveland Division of Fire has available forms to request access to your “PHI” and will provide a written response if you are denied access and let you know your appeal rights. You also have the right to receive confidential communications of your “PHI”. If you wish to inspect and copy your medical information, contact the Cleveland Division of Fire’s Privacy Officer.
- **The right to amend your “PHI”:** You have the right to ask the Cleveland Division of Fire to amend written medical information that we may have about you. The Cleveland Division of Fire will generally amend your information within 60 days of your request and will notify you when we have amended the information. The Cleveland Division of Fire is permitted by law to deny your request to amend your medical information only in certain circumstances, if the information you have asked the Cleveland Division of Fire to amend is not correct. If you wish to request that the Cleveland Division of Fire amend your medical information, contact the Cleveland Division of Fire’s Privacy Officer.
- **The right to request an accounting:** You may request an accounting from the Cleveland Division of Fire of certain disclosures of your medical information that the Cleveland Division of Fire has made in the six years prior to the date of your request. The Cleveland Division of Fire is not required to give you an accounting of information that was used or disclosed for purposes of treatment, payment or health care operations, or when your health information was shared with our business associates, like billing company or a medical facility from/to which the Cleveland Division of Fire may have transported you. The Cleveland Division of Fire is also not required to give you an accounting of the uses of protected health information for which you have already given the Cleveland Division of Fire written authorization. If you wish to request an accounting, contact the Cleveland Division of Fire’s Privacy Officer.
- **The right to request that the Cleveland Division of Fire restricts the uses and disclosures of your “PHI”:** You have the right to request that the Cleveland Division of Fire restrict how the medical information we have about you is used and

disclosed. The Cleveland Division of Fire is not required to agree to any restrictions you request, but any restrictions agreed to by the Cleveland Division of Fire in writing are binding on the Cleveland Division of Fire.

- **Internet, Electronic Mail and the Right to Obtain a Copy of Paper Notice on Request:** The Cleveland Division of Fire will prominently post a copy of this Notice on the web site; if one is maintained. If requested, the Cleveland Division of Fire will forward this Notice by electronic mail. You may always request a paper copy of this Notice.

***Revisions to the Notice:***

The Cleveland Division of Fire reserves the right to change the terms of this Notice at any time, and the changes will be effective immediately and will apply to all “PHI” that is maintained. Any material changes to the Notice will be promptly posted at Cleveland Emergency Medical facilities and web site, if one is maintained. You can get a copy of the latest version of this Notice by contacting the Cleveland Division of Fire’s Privacy Officer.

***Your Legal Rights and Complaints:***

You also have the right to complain to the Cleveland Division of Fire, or to the Secretary of the United States Department of Health and Human Services if you believe your privacy rights have been violated. You will not be retaliated against in any way for filing a complaint with the Cleveland Division of Fire or to the government. Should you have any questions, comments, or complaints, direct all inquiries to the Cleveland Division of Fire’s Privacy Officer.

***Notice of Breach of Unsecured Protected Health Information:***

The Cleveland Division of Fire will promptly notify each affected individual as required for breaches of unsecured “PHI”.
